Net investment income distribution shown for class I or class A shares; distributions for other classes will differ based on class specific 12B-1 expenses. The gain distribution amounts apply equally to all classes. Short-term gains are considered ordinary income on Form 1099.

To receive a distribution, you must be a registered shareholder of the fund as of December 21, 2009, the record date; except for the fund of funds, the record date is December 29, 2009. Distributions are payable the day after the record date.
