



Section 19(a) Notice

May 19, 2016 – Duff & Phelps Select Energy MLP Fund Inc. (NYSE: DSE) declared a distribution of \$0.22 per share to shareholders of record at the close of business on May 12, 2016, payable May 19, 2016. The Fund estimates that 100 percent of the distribution is attributable to return of capital. All amounts are based on U.S. generally accepted accounting principles which may differ from federal income tax regulations.
