

Virtus Mutual Funds 2017 Year-End Distribution Estimates as of 10/24/17



It is important to note that these indicators are preliminary estimates of payments that will be made in December, based on available information as of October 24, 2017.

Actual distributions will be based on taxable realized gains and losses through October 31 and net investment income through December 31, and may be substantially different based on trading, redemptions, and market conditions. Other factors which can change the estimates include the number of shareholders of record, net operating losses, and tax and accounting related adjustments.
