**Rampart Investment Management Added as Subadviser  
on Three Virtus Closed-End Funds**

**Hartford, CT October 15, 2018** – [Rampart Investment Management](#), an investment management affiliate of Virtus Investment Partners that specializes in options strategies, has been appointed as an additional investment subadviser to manage the existing options overlay strategy on three closed-end funds, [Virtus Global Multi-Sector Income Fund](#) (NYSE: VGI), [Virtus Global Dividend & Income Fund Inc.](#) (NYSE: ZTR), and [Virtus Total Return Fund Inc.](#) (NYSE: ZF), effective today. Warun Kumar, chief investment officer, Rampart, who previously managed the strategy through Newfleet Asset Management, has been added as a portfolio manager to the funds.

The options overlay strategy is designed to generate incremental capital gains, which may be distributed to shareholders, through the purchase and sale of out-of-the-money puts and calls. This strategy seeks to exploit pricing inefficiencies in the S&P 500<sup>®</sup> Index options market by selling put and call spreads.
