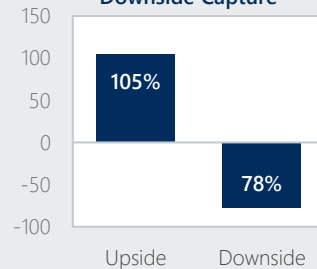

Risk vs. Return

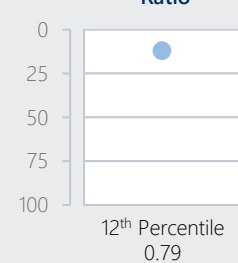
St. Dev. vs. Return Since Inception

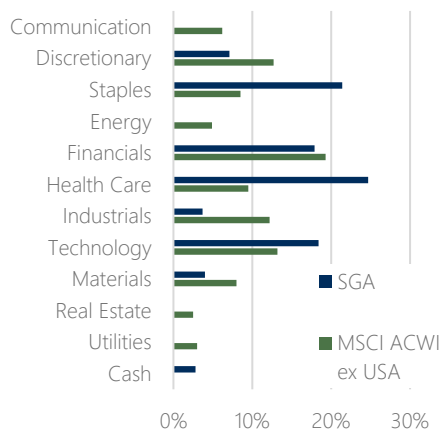

Q3 2021 Review

- Global markets took a breather in Q3 as concerns over rising COVID-19 cases, stubborn inflationary pressures, and growing geopolitical threats clouded outlook, valuations remained high
- European markets performed best while Asian markets lagged with Chinese equities among the worst performers; Developed Markets outperformed EMs
- Market leadership fluctuated with growth leading initially, then value outperforming strongly to end the quarter; small caps outperformed large caps
- Energy and Financials performed the best, while Consumer Discretionary and Communication Services performed the worst
- The reward to higher business quality characteristics fluctuated widely during the quarter; companies with earnings outperformed

SGA International Growth WRAP Composite contains fee-paying and non-fee paying large cap international growth equity portfolios under full discretionary management of the firm. For comparison purposes the composite is measured against the MSCI ACWI ex-USA TR Index (Net) and MSCI ACWI Growth ex-USA TR Index (Net).

The composite includes non-wrap accounts only, from 3/1/15 to 12/31/20.

The composite calculation has been appropriately weighted for the size of each portfolio on a time-weighted, total return basis. Monthly portfolio returns have been used in the construction of the composite. Results are based on fully discretionary accounts under management, including those accounts no longer with the firm.

The U.S. Dollar is the currency used to express performance. Results are presented gross and net of management fees and include the reinvestment of all income. For interest and capital gains, SGA does not withhold taxes. For dividends, SGA will withhold taxes as reported by the Client's custodian. Returns are calculated net of withholding taxes on dividends. Wrap fees include management, transaction, custody and other administrative fees. The Net Returns are calculated based upon the highest published fees. The net performance has been calculated by reducing the gross performance by the amount of the highest published wrap fee that may be charged to SGA clients, 3.00%, employing the International Growth WRAP strategy during the period under consideration.
