The following information may be of value in reducing your state or local tax liability for dividend income received from Virtus Dividend, Interest & Premium Strategy Fund (Formerly known as AllianzGI Dividend, Interest & Premium Strategy Fund) ("the Fund").

Certain states exempt interest earned on obligations of the federal government from state and local taxes. However, the exemption requirements vary from state to state. For example, certain states require that a minimum percentage (typically 50%) of a fund's assets consist of U.S. Government securities at the end of each quarter. The Fund did not satisfy this limitation. The Fund did not earn income from investments in U.S. Government Obligations or repurchase agreements.
