Investment Opportunity

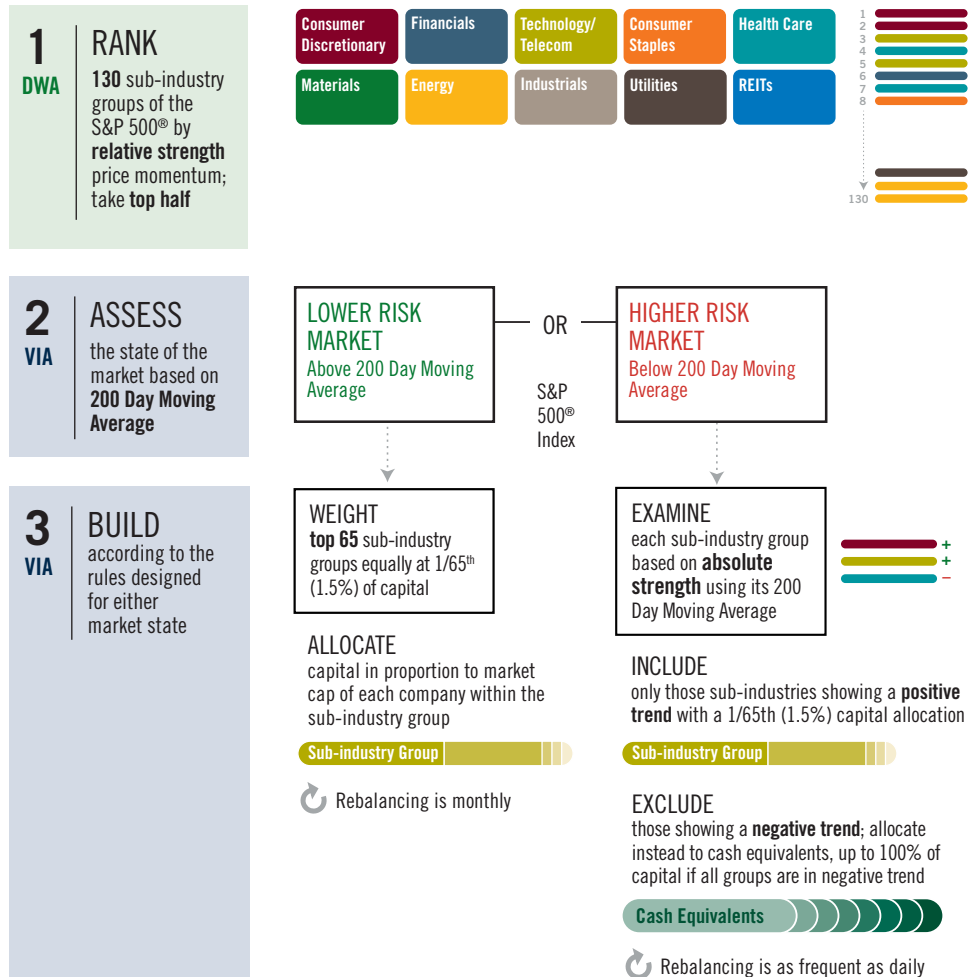
The Virtus Equity Trend Fund strives to participate in rising markets while placing an emphasis on preserving capital during major market declines. The Fund has an investment objective of long-term capital appreciation. It aims to deliver attractive returns with lower volatility, beta, and correlation over full market cycles.

Effective May 11, 2015, this fund changed its strategy and its name. Performance prior to this date reflects previous fund management. This document reflects the new investment process.

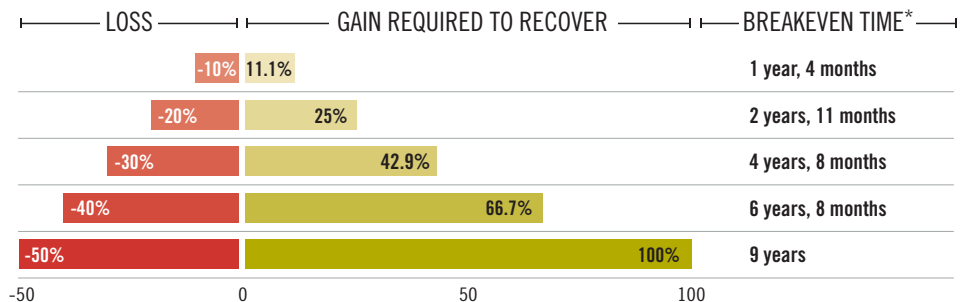
Effective August 25, 2017, Rampart Investment Management Company, LLC has been named investment subadviser.

Investment Process

The Virtus Equity Trend Fund employs relative strength analysis provided by Dorsey, Wright & Associates (DWA) to construct a risk-managed portfolio of U.S. equities, prioritizing market segments with the strongest price momentum. Cash equivalents are used for defensive purposes as the model indicates.

Effective May 11, 2015, this fund changed its strategy and its name. The portfolio was fully transitioned to the new manager's strategy on 5/19/15. Performance since manager change is shown from 5/19/15 in addition to the Fund's historic record to illustrate the performance of the new manager's strategy.

The fund class gross expense ratio is 1.61% and reflects the direct and indirect expenses paid by the Fund. The gross expense ratio minus the indirect expenses incurred by the underlying funds in which the Fund invests is 1.42%.

Average annual total returns reflect the change in share price and the reinvestment of all dividends and capital gains. Net Asset Value (NAV) returns do not reflect the deduction of any sales charges. POP (Public Offering Price) performance reflects the deduction of the maximum sales charge of 5.75%. GLOSSARY

R²: a measure of how closely a portfolio's performance correlates with the performance of a benchmark index.

Beta: a quantitative measure of the volatility of a given portfolio to the overall market. Higher beta suggests higher volatility.

Standard Deviation: measures variability of returns around the average return for an investment portfolio. Higher standard deviation suggests greater risk.

Max Drawdown: the peak to trough decline for an investment during a time period. A smaller maximum drawdown is desirable because that means that the strategy has less of a decline from a high point to a low point.

Correlation Coefficient: a measure that determines the degree to which two variables' movements are associated. The correlation coefficient will vary from -1 to +1. A -1 indicates perfect negative correlation and +1 indicates perfect positive correlation.
