

Market Overview

Investors embraced risk in the first quarter and propelled U.S. equities to extend their fourth quarter gains. This, despite the second and third largest bank failures on record and a Federal Reserve (Fed) committed to tightening monetary policy to combat lingering inflation. One of last year's hardest-hit sectors, technology, staged a comeback as interest rates pulled back and the sector was perceived as a haven amidst the banking turmoil. Within the benchmark Russell 2000® Value Index, technology and consumer discretionary led with double-digit gains, followed by strength from the materials and industrials sectors. In contrast, financials plummeted on instability in the regional bank space, followed by weakness from the health care, energy, and real estate sectors.

Portfolio Overview

The NFJ Small-Cap Value Wrap Strategy outperformed the Russell 2000 Value benchmark Index over the quarter. Positive stock selection drove outperformance, though sector allocations also contributed to relative returns.

Portfolio Contributors

Stock selection was robust across the health care and financials sectors. An overweight in the Index's best-performing sector—technology—also contributed to quarterly results. **KB Home** and **Allegiant Travel** were the strongest absolute contributors.

Homebuilders generally rebounded given a pullback in mortgage rates and onset of the spring building season. **KB Home** completed FY22 with a \$3.7 billion backlog, and management authorized a new \$500 million share repurchase program.

Adjusted net income for **Allegiant Travel** was ahead of expectations on strong 4Q demand that continued into early 2023. Management is confident in the company's competitive position, with the view that low fares and non-stop flights will continue to drive consumer loyalty.

Over the course of three decades, NFJ Investment Group's commitment to value has remained steadfast. Our investment process – built upon the principles of Benjamin Graham, the father of value investing – has stayed true to the philosophy of the firm's founders while continuing to evolve in the hands of their successors through the integration of new technological capabilities and advanced analytics methods that enhance the research process.

Portfolio Detractors

Stock picking was negative in the real estate and technology sectors. An underweight in real estate marginally detracted from quarterly results. **Columbia Banking System** and **PacWest Bancorp** were the strongest absolute detractors.

Shares of **Columbia Banking System** were caught up in contagion fears toward the end of the quarter. The company completed its merger with Umpqua Holdings, in a move that expanded capabilities and enhanced products and services to clients of one of the largest banks headquartered in the West.

Like many other U.S. regional banks, **PacWest Bancorp** traded downward on contagion fears. We exited the position on risk management concerns.

Outlook

The U.S. economy continues to tiptoe to the edge of a recession, with the latest economic data showing signs of cracks in the labor market. That said, unemployment remains near historical lows, and consumers still have a solid cash cushion. The key focus for investors is the divergence between what the Fed says and what investors believe the Fed will ultimately do, and where rates finish the year.

Forecasts show the fed funds rate holding at around 5% through the end of 2023. However, the futures market has priced in capitulation, with the Fed cutting rates by at least 50 basis points this year. Should the futures market prove correct, such a reversal appears largely priced into markets. However, should Fed Chair Powell hold rates firm through year-end, stocks could react unfavorably, implying more downside than upside risk at present levels.

Currently, U.S. stocks are not particularly cheap, with the S&P 500® Index trading at more than 18 times forward earnings. However, consecutive years in the red are rare for U.S. equities, and while much of 2023's gains may already be in the books, further gains could be augmented by attractive and growing dividend yields. We believe NFJ portfolios, which seek to invest in stocks with attractive dividends and dividend growth, are well positioned for this type of environment.

The Firm: The firm is defined as NFJ Investment Group, LLC (“NFJ”), a Registered Investment Advisor with the SEC. NFJ is an affiliated investment manager of Virtus Investment Partners, Inc. (“Virtus”). NFJ was founded in February 1989 with funding from Pacific Financial Asset Management Corp (“PFAMCo”). In 1994 PFAMCo merged with Thomson Advisory Group LP and became PIMCO Advisors. In 2000 Allianz AG acquired PIMCO Advisors, including NFJ. In 2010, Allianz Global Investors US LLC was formed, including NFJ. In July 2017 NFJ rolled up their RIA designation within Allianz Global Investors US LLC. At this time NFJ became a division of Allianz Global Investors LLC (“AllianzGI”) and was no longer independently registered with the SEC. Effective February 1, 2021, in connection with a strategic partnership between Virtus and AllianzGI, NFJ moved from AllianzGI and registered with the SEC as a newly established investment advisory subsidiary of Virtus. The firm definition includes all investment portfolios managed directly or indirectly by NFJ including institutional, pooled fund and wrap fee accounts.

NFJ claims compliance with the Global Investment Performance Standards (GIPS®) and has prepared and presented this report in compliance with the GIPS standards. NFJ has been independently verified for the periods February 1, 2021 to March 31, 2021. A firm that claims compliance with the GIPS standards must establish policies and procedures for complying with all the applicable requirements of the GIPS standards. Verification provides assurance on whether the firm’s policies and procedures related to composite and pooled fund maintenance, as well as the calculation, presentation, and distribution of performance, have been designed in compliance with the GIPS standards and have been implemented on a firm-wide basis. The Composite: The NFJ Small Cap Value Wrap Composite (the “Composite”) consists of portfolios that invest in a diversified group of small capitalization stocks considered to have attractive valuations and return value to shareholders. Each company typically has a minimum market capitalization of at least \$100 million at purchase. The Composite was created February 1, 2021 and has a performance inception date of January 1, 2011. Composite performance is linked to composite performance generated at a prior firm for all periods prior to the composite creation date. The Composite includes all discretionary wrap fee portfolios with comparable investment objectives and risks, managed by NFJ for at least one full month. The Composite can include both tax-exempt and taxable accounts. No leverage has been used in the accounts included in the Composite. The Composite includes only wrap fee accounts.

A list of composite descriptions is available upon request. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request.

Portfolio Returns: Returns are calculated on a total return basis, including all dividends and interest, accrued income, realized and unrealized gains or losses reinvestment of dividends and other earnings. Performance results are expressed in U.S. dollars. Returns are presented gross and net of fees. Gross of fees performance results are “pure” gross and are provided as supplemental information, as results have not been reduced by advisory and sponsor fees (including trading and custodial fees). Net of fee returns have been reduced by the highest applicable managed account fee of 3.00% applied on a quarterly basis. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request.

Fees: The managed account fee is a bundled fee (3.00%) inclusive of advisory, trading, custodial and administrative fees. There are no fees charged to clients at the commingled level; sponsor and advisory fees apply to the account as a whole. Actual fees incurred by client accounts may vary. Index: The Russell 2000 Value Index measures the performance of the 2,000 smallest companies in the Russell 3000 Index with lower price-to-book ratios and lower forecasted growth values. The Russell 3000 Index measures the performance of the 3,000 largest U.S. companies based on total market capitalization. This unmanaged market index is provided to represent the investment environment existing during the time periods shown. The index is referred to for comparative purposes only and is not intended to parallel the risk or investment style of the portfolios in the Composite. For comparison purposes, the index is fully invested, which includes reinvestment of income. The returns for this unmanaged index do not include any transaction costs, management fees or other costs. For periods where there were 5 or fewer portfolios in the composite for the full period the internal dispersion statistic is not meaningful and is shown as “N/A”. **Past performance is not indicative of future results.**
