

**VIRTUS CONVERTIBLE & INCOME FUND ANNOUNCES QUARTERLY DISTRIBUTION:  
5.625% SERIES A CUMULATIVE PREFERRED SHARES**

**HARTFORD, CT, February 28, 2023** - [Virtus Convertible & Income Fund](#) (NYSE: NCV), announced today that it has declared a \$0.3515625 per share cash distribution payable on March 31, 2023 to Series A cumulative preferred shareholders of record on March 13, 2023.

The Series A Cumulative Preferred Shares, which trade on the New York Stock Exchange under the symbol NCV PR A, are rated “A” by Fitch Ratings and have an annual dividend rate of \$1.40625 per share. The 4,000,000 Series A Cumulative Preferred Shares were issued September 20, 2018 at \$25.00 per share and pay distributions quarterly. This distribution represents the accrual period from January 1, 2023 through March 31, 2023. The Series A Cumulative Preferred Shares will be callable at any time at the liquidation value of \$25.00 per share plus accrued dividends from and after the expiration of a five-year non-call period on September 20, 2023.
