

## Virtus Artificial Intelligence & Technology Opportunities Fund Discloses Sources of Distribution – Section 19(a) Notice

**HARTFORD, CT, August 15, 2023** -- [Virtus Artificial Intelligence & Technology Opportunities Fund](#) (NYSE: AIO) previously announced the following monthly distribution on May 25, 2023:

Under the terms of its Managed Distribution Plan, the Fund will seek to maintain a consistent distribution level that may be paid, in part or in full, from net investment income and realized capital gains, or a combination thereof. Shareholders should note, however, that if the Fund's aggregate net investment income and net realized capital gains are less than the amount of the distribution level, the difference will be distributed from the Fund's assets and will constitute a return of the shareholder's capital. You should not draw any conclusions about the Fund's investment performance from the amount of this distribution or from the terms of the Fund's Managed Distribution Plan.

The Fund estimates that it has distributed more than its income and capital gains; therefore, a portion of your distribution may be a return of capital. A return of capital may occur, for example, when some or all of the money that you invested in the Fund is paid back to you. A return of capital distribution does not necessarily reflect the Fund's investment performance and should not be confused with 'yield' or 'income'.

- (5) Fiscal YTD Cumulative Distribution Rate is the dollar value of distributions from the first day of the fiscal year to this month end as a percentage of the Fund's NAV at month end.

The Fund has a limited term and will terminate on or around October 29, 2031 absent Trustee and shareholder approval to amend the limited term provision of the Fund's Amended and Restated Agreement and Declaration of Trust, as provided therein. Virtus Investment Advisers, Inc. is the investment adviser to the Fund and [Voya Investment Management](#) is its subadviser.
