14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On March 15, 2024, Virtus Seix High Yield Fund acquired all of the assets and assumed all of the liabilities of the Issuer in exchange for voting shares of beneficial interest. The Issuer distributed the shares received to its shareholders in exchange for their shares of the Issuer in complete liquidation and termination of the Issuer. The merger of Virtus Seix High Yield Income Fund into Virtus Seix High Yield Fund qualifies as a tax-free reorganization within the meaning of Internal Revenue Code §368(a).

The exchange is based on the number and value of shares outstanding at the close of business March 15, 2024 (see attached).

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ A shareholder's aggregate basis in the shares of Virtus Seix High Yield Fund they received in exchange for their shares of Virtus Seix High Yield Income Fund will be the same as their aggregate basis in shares of Virtus Seix High Yield Income Fund surrendered. The number of Virtus Seix High Yield Fund shares that were received for each share of Virtus Seix High Yield Income Fund surrendered in the exchange is detailed in the attached.

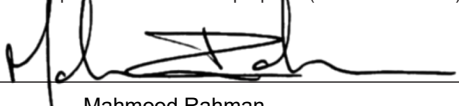
