14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶

On July 31, 2015, RidgeWorth Funds - Core Bond Fund (EIN: 23-2678682) acquired all of the assets and assumed all of the liabilities of RidgeWorth Funds - Intermediate Bond Fund (EIN: 13-4074101), in a tax-free exchange of shares and the subsequent liquidation of RidgeWorth Funds - Intermediate Bond Fund (the "Reorganization").

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶

On July 31, 2015, the closing net asset value per share ("NAV"), before the merger, for the RidgeWorth Funds - Intermediate Bond Fund (EIN: 13-4074101) on a class level is as follows: Class I (SAMIX) 9.72, Class A (IBASX) 9.73, and Class R (IBLSX) 9.72. RidgeWorth Funds - Core Bond Fund's (EIN: 23-2678682) closing net asset value per share ("NAV"), before the merger, on a class level is as follows: Class I (STIGX) 10.77, Class A (STGIX) 10.76, and Class R (SCIGX) 10.77. These NAV's generated a merger conversion ratio that resulted in the RidgeWorth Funds - Intermediate Bond Fund shareholders receiving 0.90 Class I shares, 0.90 Class A shares, and 0.90 Class R shares of the RidgeWorth Funds - Core Bond Fund for each of the RidgeWorth Funds - Intermediate Bond Fund Class I, Class A, and Class R shares previously held. The closing net asset value per share ("NAV"), after the merger, for the RidgeWorth Funds - Core Bond Fund (EIN: 23-2678682) on a class level is as follows: Class I (STIGX) 10.77, Class A (STGIX) 10.76 and Class R (SCIGX) 10.77.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶

The basis of the assets of the RidgeWorth Funds - Intermediate Bond Fund received by the RidgeWorth Funds - Core Bond Fund was the same as the basis of such assets in the hands of the RidgeWorth Funds - Intermediate Bond Fund immediately prior to the reorganization. Likewise, the basis of the RidgeWorth Funds - Core Bond Fund Shares received by each shareholder of the RidgeWorth Funds - Intermediate Bond Fund was the same as the basis in the RidgeWorth Funds - Intermediate Bond Fund Shares, as applicable, surrendered in exchange therefor and in accordance with the ratios noted above.
