**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶

On March 1, 2013, RidgeWorth Large Cap Growth Stock Fund (EIN: 23-2678693) acquired all of the assets and assumed all of the liabilities of RidgeWorth Large Cap Core Growth Stock Fund (EIN: 04-3161804), in a tax-free exchange of shares and the subsequent liquidation of RidgeWorth Large Cap Core Growth Stock Fund (the "Reorganization").

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶

On March 1, 2013, the closing net asset value per share ("NAV"), before the merger, for the RidgeWorth Funds - Large Cap Core Growth Stock Fund (EIN: 04-3161804) on a class level is as follows: Class I (CRVAX) 15.55, Class A (CFVIX) 15.69, and Class C (CVIBX) 15.10. RidgeWorth Funds - Large Cap Growth Stock Fund's (EIN: 23-2678693) closing net asset value per share ("NAV"), before the merger, on a class level is as follows: Class I (STCAX) 8.11, Class A (STCIX) 7.09, and Class C (STCFX) 5.58. These NAV's generated a merger conversion ratio that resulted in the RidgeWorth Funds - Large Cap Core Growth Stock Fund shareholders receiving 1.92 Class I shares, 2.21 Class A shares, and 2.71 Class C shares of the RidgeWorth Funds - Large Cap Growth Stock Fund for each RidgeWorth Funds - Large Cap Core Growth Stock Fund Class I, Class A, and Class C shares previously held. The closing net asset value per share ("NAV"), after the merger, for the RidgeWorth Funds - Large Cap Growth Stock Fund (EIN: 23-2678693) on a class level is as follows: Class I (STCAX) 8.11, Class A (STCIX) 7.09, and Class C (STCFX) 5.58.

**16** Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶

The basis of the assets of the RidgeWorth Funds - Large Cap Core Growth Stock Fund received by the RidgeWorth Funds - Large Cap Growth Stock Fund was the same as the basis of such assets in the hands of the RidgeWorth Funds - Large Cap Core Growth Stock Fund immediately prior to the reorganization. Likewise, the basis of the RidgeWorth Funds - Large Cap Growth Stock Fund Shares received by each shareholder of the RidgeWorth Funds - Large Cap Core Growth Stock Fund was the same as the basis in the RidgeWorth Funds - Large Cap Core Growth Stock Fund Shares, as applicable, surrendered in exchange therefor and in accordance with the ratios noted above.
